"WHY I CHOSE THE MLAW COURSE"

Tamara McGaughey is an MLaw student in her final year at Leeds Law School. The MLaw is an integrated master's course that joins the academic parts of a degree with the vocational training needed to qualify as a solicitor. She offers some advice to other aspiring solicitors considering the course.

"During my final year of undergraduate studies in Law, I knew I wanted to become a solicitor and would need to do either the Legal Practice Course or SQE to do so. The MLaw lets me do the LPC without the requirement to complete a separate master's and provides the same funding as undergraduate students get. I come from a low-income background, so being able to access the maintenance loan has helped me greatly in terms of financial security."



"Even though the lecturers explain how much is expected of you for this professional course, I was still overwhelmed in the transition from LLB Law to MLaw. You are effectively doing at least triple the workload, in university approximately 18 hours a week, all whilst completing exams. I have had to be prepared, disciplined and organised."

"Leeds Law School has not only helped me with career advice and legal knowledge, but has also helped my confidence grow significantly. My long-term goal is to become a Solicitor with higher rights of audience. Leeds Law School has really pushed me in the right direction with advocacy skills."

"The MLaw is a very demanding course and you will have to make sacrifices to make it work, but just work hard and be consistent and it will be worth it: it's brilliant!"

FOCUS ON: LEGAL AND Employability Skills Module

The Legal and Employability Skills module is a core module for all first-year students. We spoke to Dr Jill Dickinson, Module Leader, to find out why it's bigger and better than ever.



Hi Jill! Tell us why this module is so popular with students.

It provides real, practical opportunities for first year students to further develop their transferable skills, confidence, and contact networks to support them with applications for work placements and graduate recruitment.

What can students get involved with on this module?

Students engage in a variety of simulated activities such as speed networking, client interviews, an assessment centre, and taking on the role of recruiters in assessing and evaluating CVs and mock career interviews.

We also work with employers in the design and delivery of the module; for example, this term a solicitor from a global law firm worked with us to develop some materials around the importance of developing a professional social media profile, and two alumni provided top tips to stand out in interviews.

We also have a comprehensive guest speaker series with different law practitioners.

Who teaches on this module?

The module involves colleagues from both Leeds Law School, including Academic Advisors, and across the university, including: Careers, Skills for Learning, the Library Team, Wellbeing, Experiential Learning, alongside alumni and practitioners.

What does it look like in practice?

We share pre-recorded materials with students each week and then have live, large group sessions which are held in a lecture theatre, often with guest speakers and an audience Q&A. Th e students also have fortnightly seminars on particular themes, such as developing communication skills, building a professional profile, and recruitment and selection.

How long does it last for?

The module runs in semester 2 (January-May), so for 12 weeks in total. For the assessment, students are asked to choose a job advert and tailor a pre-recorded extract from a careers interview, and a CV and covering letter to that advert.

How can students use the skills they learn going forward into their studies?

From the start, the module includes opportunities for students to develop their skills and confidence; for example, around independent study, research, communication skills, and time management. They also learn teamwork and collaboration through group assessment work, as well as analytical skills and problem-solving.
